Every horse that is not a full-time boarder at Seven Oaks Ranch is considered a haul-in and must pay a **\$15 haul-in fee per horse per day** (this includes horses coming for lessons, clinics or pleasure riding).

Health Requirements (Veterinary Documentation)

- Annual: Rabies, West Nile, Tetanus, EEE/WEE
- Negative Coggins annually
- Influenza/Rhinopneumonitis every 6 months
- Strangles vaccination yearly (intranasal or IM)

I understand that horseback riding and equine activities are inherently dangerous. In consideration of being permitted to haul my horse onto or bring a horse I am training onto Seven Oaks Ranch, I agree to the following:

1. I assume all risk of injury or death to myself, my horse, and any minors under my control.
2. I release Seven Oaks Ranch, its owners, employees, and agents from any liability for injury, death, or property damage arising from equine activities on the premises.
3. I have paid the required **\$15 per horse per day** haul-in/facility fee
4. I have provided veterinary certificate for proof of vaccinations/Coggins.
5. I agree to publicly posted ranch rules.

Resident Trainers, Outside Trainers, & Instructors Policy

To ensure the safety and professionalism of all activities at Seven Oaks Ranch, the following guidelines apply to any trainer or riding instructor:

- **Pre-Approval Required**

All outside trainers must receive prior approval from Seven Oaks Ranch management before providing services on the property.

- **Outside Trainer Insurance Requirements**

Outside Trainers must provide current proof of liability insurance. No instruction may take place until documentation is received and approved.

- **Compliance with Ranch Rules**

All Trainers, Outside Trainers, Instructors, and their clients are required to follow Seven Oaks Ranch rules, safety protocols, and hours of operation at all times.

- **Resident Trainer Obligations**

Trainers must maintain their own equine liability coverage with at least \$1M in liability coverage and name Gentry Farms LLC as landowner.
